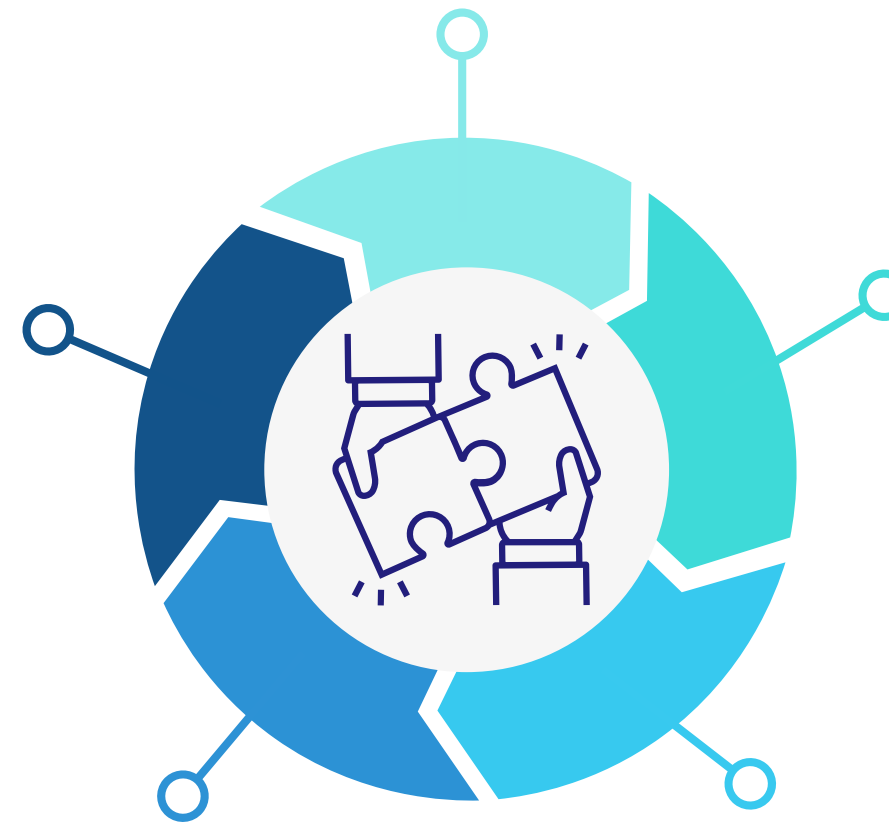

CLUSTERS

It facilitates funding for industry-led mid- to long-term R&D projects that can include organizations along a whole value chain.

NETWORK PROJECTS

Bottom-up cooperation program, where national funding bodies cooperate and launch bilateral and multilateral calls for projects



INVESTMENT READINESS

It supports collaboration between up to 500 highly innovative SMEs and investors or large companies.

INNOWIDE

It funds innovative SMEs to assess the viability of commercial or research ambitions for internationalization in a target country

EUROSTAR

Funding instrument that supports innovative SMEs and project partners by funding international collaborative R&D and innovation projects.

Flexible funding program for international R&D projects, where national funding bodies cooperate and launch bilateral and multilateral calls for projects.

It eases collaboration between organizations in Eureka countries offering you the freedom to design your project proposal and build your ideal consortium.

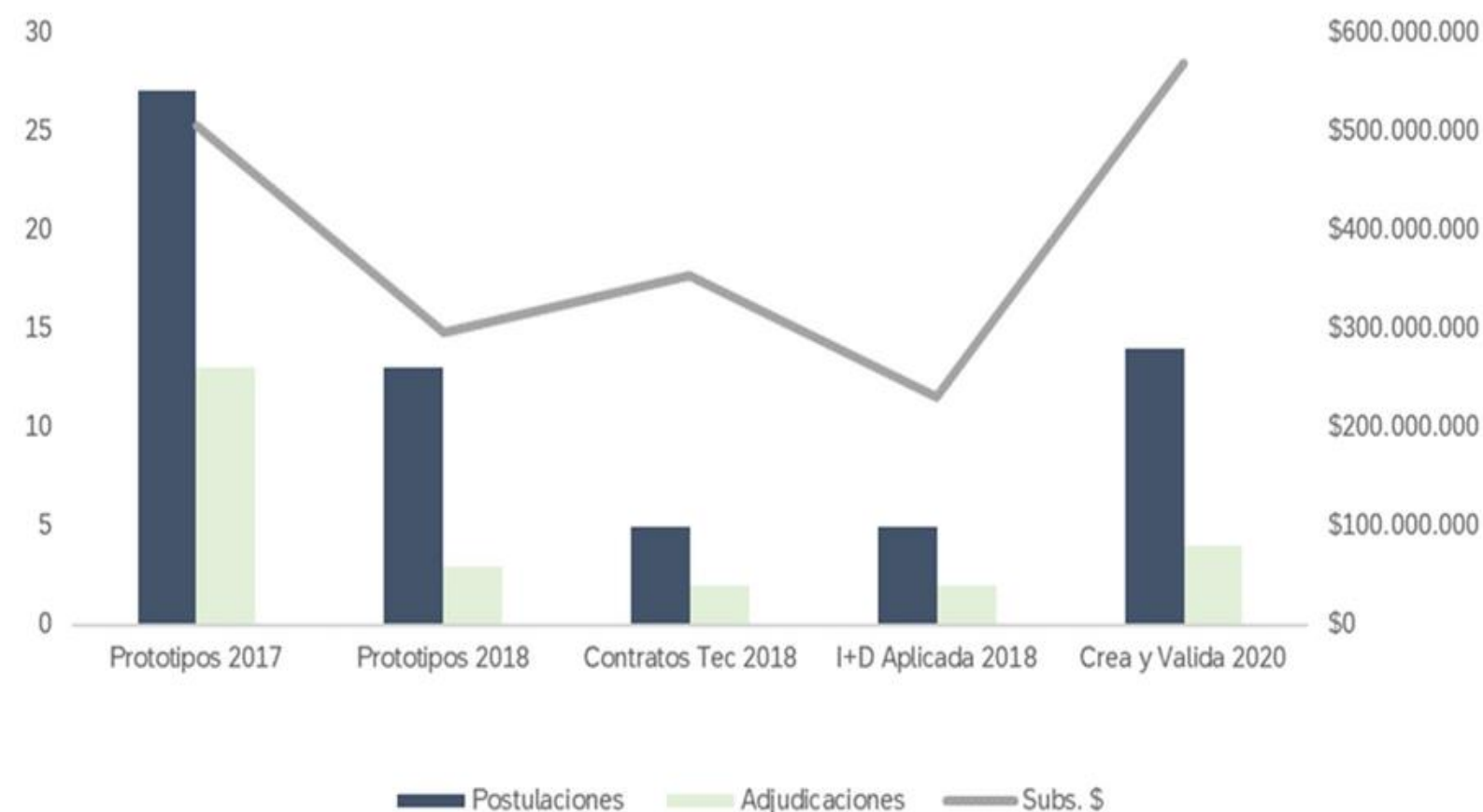


PROJECT

1. Your project idea must represent cooperation in the form of a specific project.
2. The project must be directed at researching or developing a product, process or service.
3. The project must have a civilian purpose.
4. Your consortium must include at least two independent legal entities from at least two Eureka countries.

CALL 2022 Eureka Network Projects

CORFO together with FFG from Austria, VLAIO, SPW and Innoviris from Belgium, Bpifrance from France and CDTI from Spain, launched a multilateral call of Network Projects for collaborative R&D+i projects led by private companies.

THE CALL CLOSES ON 10 APRIL 2024

The national funding bodies from Belgium (Flanders), Chile, France, and Spain have allocated funding for organisations collaborating on international R&D projects that target green technologies such as energy, water, farming forestry, pollution waste, transportation, circular economy and building construction.

You can submit your R&D project application for this call for Eureka Network projects between 28 November 2023 and 10 April 2024. Your project consortium must include at least two firms from two different countries participating in this call for projects.

Research institutes/universities and other organisations are welcome to participate in collaboration with companies (according to each country's funding regulations).

FOCUS OF THIS CALL GREEN TECHNOLOGIES

In general, green technologies are considered those that “protect the environment, are less polluting, use all resources more sustainably, recycle more of their wastes and products, and handle residual waste in a more acceptable manner than the technologies for which they were substitutes”*

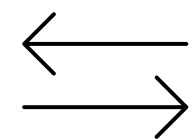

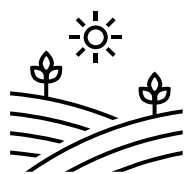

Circular Economy



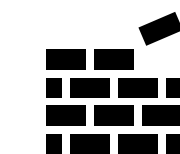

Water



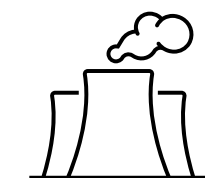
- Smart Water Metering System

WHO & WHAT?

- companies (SME and large) based in Flanders
- industrial development project
- receive up to 60% of the eligible project costs, to a maximum of 500,000 EUR per project. Staff and other costs can be funded with a 25 to 60% subsidy of the project budget, with a minimum budget equivalent to support of € 25.000
 - Basic funding rate: 25%
 - Additional rate for MEs: 10%
 - Additional rate for SEs: 20%
 - Additional rate for cross-border cooperation between companies (conditional*): 15%
- Flemish or foreign academic partners or research institutes can be funded by VLAIO if their expertise is crucial.

FINANCIAL INSTRUMENT

Crea y Valida - Eureka



All interested Chilean companies, who have successfully declared admissible in the international phase, will be allowed to apply to the financial instrument, Crea y Valida – Eureka

GOAL

Support the development of new or significantly improved products and/or processes, that require R&D, from the prototype phase to the technical validation phase at a production scale and/or commercial validation, strengthening innovation capabilities in the company.

BENEFICIARY

- Constituted legal entity in Chile.
- 24 months old (as registered in the tax office)
- Proven record of sales within the last 24 months prior to application (no need to be every month).

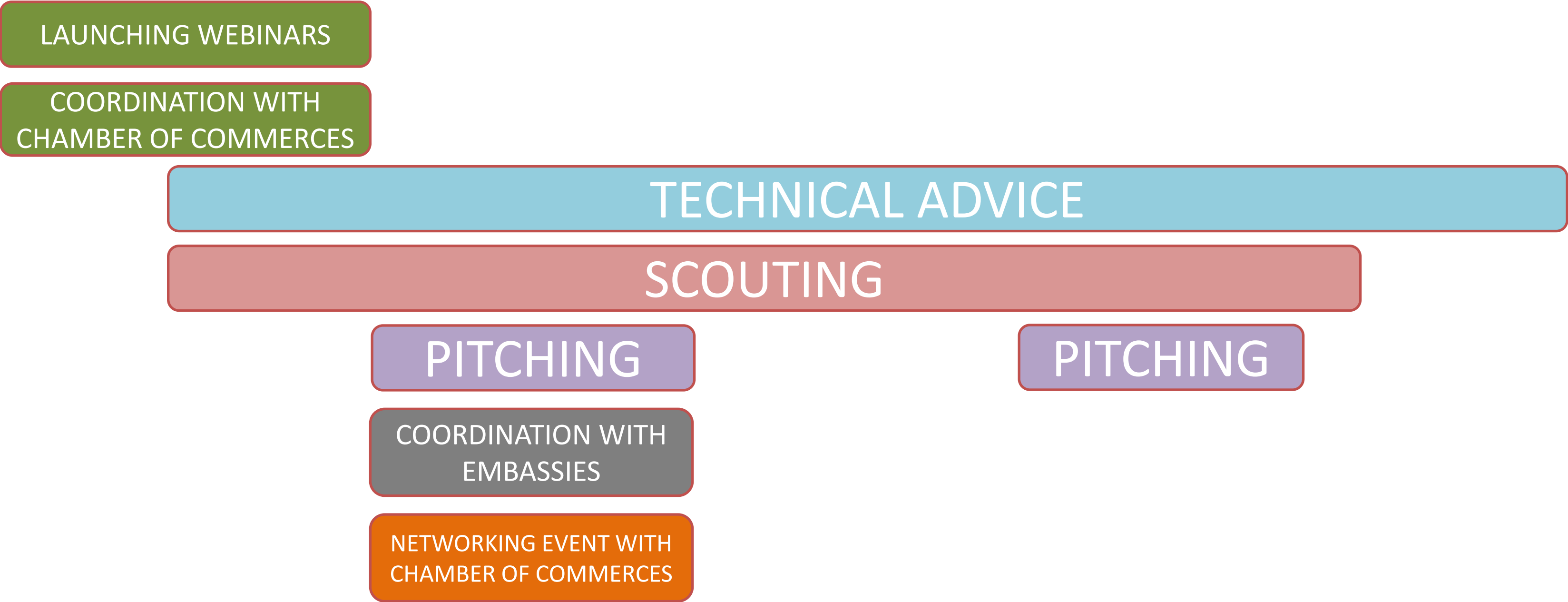

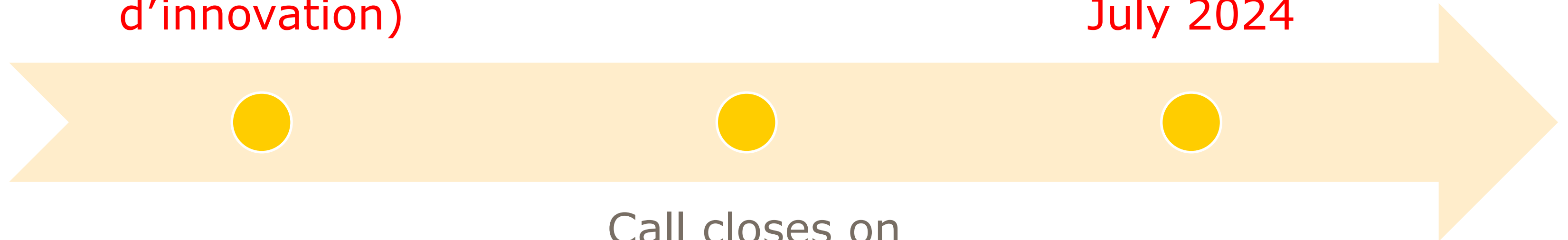
*Note that large companies with more than 2000 FTEs can participate in the consortium but will not be eligible for public funding.

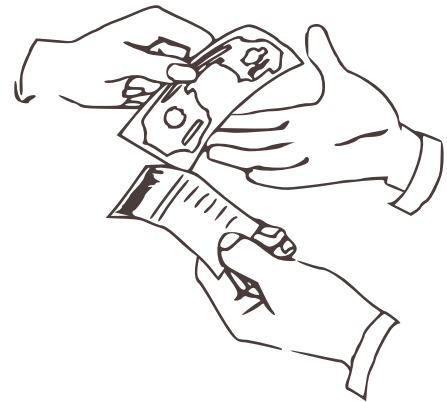

HOW DOES IT WORK?



MAXIMUM AMOUNT OF THE SERVICE

- The consulting service is limited to €25,000 excluding tax if the beneficiary company is the consortium leader, and €5,000 excluding tax if it is not the case.
- Bpifrance finances 50% of the cost up to €15,000 including tax, this aid being paid to the consultant at the end of his service.



TYPE OF CONTRACTING

- Bpifrance signs a contract with the company applying for aid and the expert consultant
- It is the French company's service provider who is paid

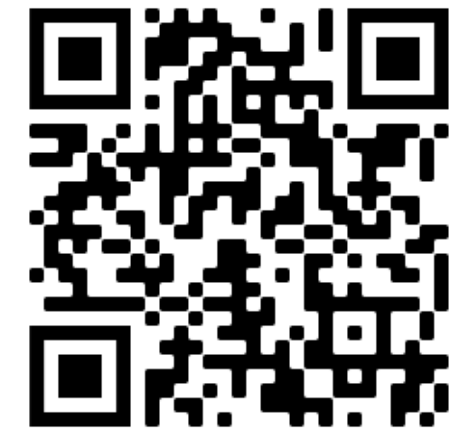

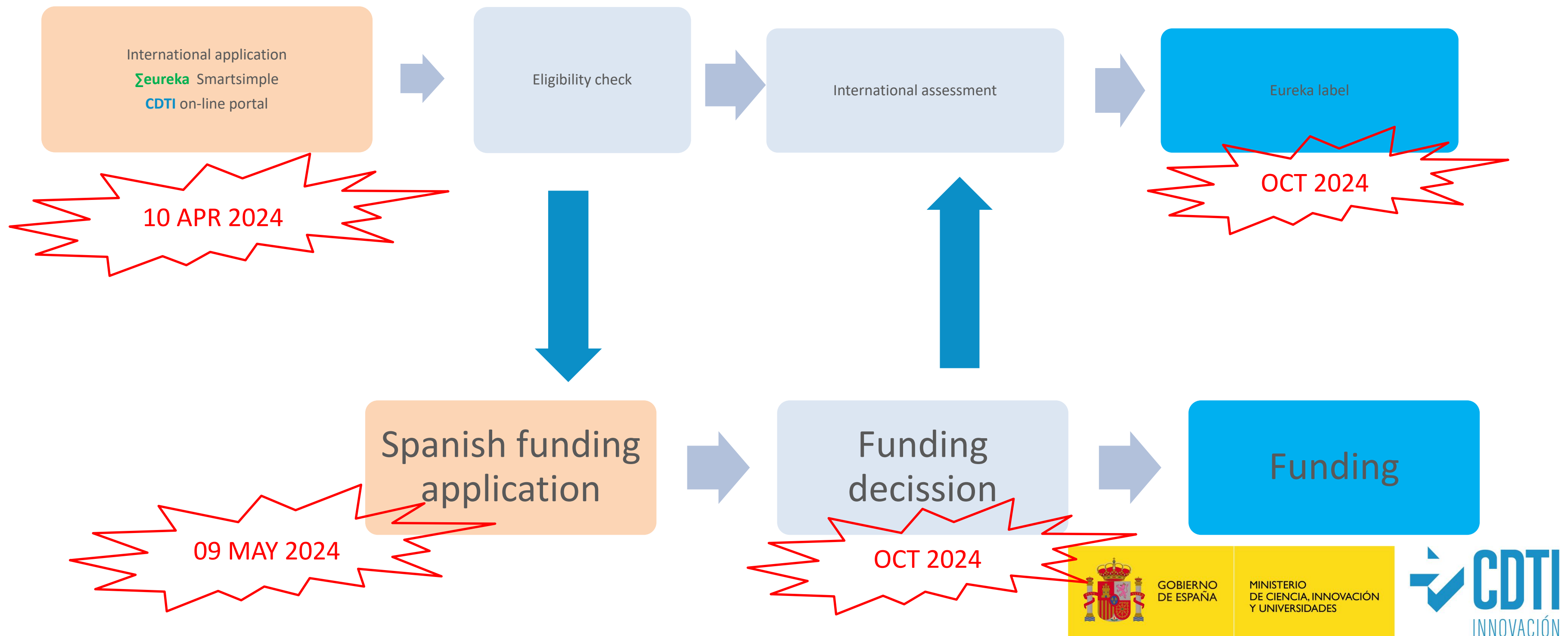
Eureka Network Projects Call

Funding in Spain

- Available budget for all projects above thresholds
- All topics are eligible and TRL goes from 4 to 6 (even 7)
- Industrial market-oriented projects
- Only for companies (both SMEs and large enterprises)
- Min budget: 175.000 €
- Multiannual funding (1-3 years)
- Loans up to 85% of the eligible budget (fixed interest rate Euribor 1 year)
- Up to 22,5% / 18,75% (SME / Large) of the eligible budget has not to be reimbursed
- Long recovery: 10 or 15 years, includes a grace period (2-3 years)
- Advances (35% when contract is signed, limit 250k€)
