COMPONENT PRODUCTION PROJECTS IN  
CHILE, APPROVED BY EXEMPT  
ELECTRONIC RESOLUTION NO. 01, OF 2025,  
THE GREEN HYDROGEN INDUSTRY  
DEVELOPMENT COMMITTEE.

#### VIEWED :

Corfo's Resolution No. 60 of 2022, which implements Council Agreement No. 3,121 of 2022, which creates the **"Green Hydrogen Industry Development Committee"** and establishes the rules that will regulate its operation and approves its regulations; amended by Council Agreement No. 3,126 of 2022, implemented by Corfo's Resolution No. 2 of 2023; Law No. 19,880, which establishes the bases of the administrative procedures that govern the bodies of state administration ; Resolution No. 36 of 2024, amended and supplemented by Resolution No. 8 of 2025, both of the Comptroller General's Office, which establishes rules on exemption from the decision-making process.

#### CONSIDERING:

1. That, within the functions assigned to the Committee, letter e) of article 2 of its Regulations, provides: *"e) Provide support for the design promotion, productive or business innovation and financing instruments, aimed at promoting a local industry of technology and service providers for the green hydrogen industry with the potential to export."*
2. That, through Exempt Electronic Resolution No. 01, of 2025, the Green Hydrogen Industry Development Committee approved the Procedure for the RFI Stage ( Request for Information ) for Wind System and/or Component Production Projects in Chile (the "Procedure"). The call for proposals was announced to interested parties on the Corfo website.
3. That, it has been deemed necessary to extend the deadline for making inquiries and clarifications established in the table contained in section 2.4 of the Procedure, without modifying the closing deadline.

**RESOLVE:**

**1° REPLACE** the table contained in section 2.4 “RFI Stage Deadlines” of the “Procedure for the RFI (Request For Information) stage of wind system and/or component production projects in Chile”, approved by Exempt Electronic Resolution No. 01, of 2025, the Green Hydrogen Industry Development Committee, by the following:

“Program of Activities and Milestones	Deadlines
Consultation and clarification period	Until July 18, 2025
Period for responding to queries	Maximum 10 business days from reception
Submission of information documents	July 30, 2025
Publication of the results of the RFI Stage	August 18, 2025

**2° PUBLISH** on the website [www.corfo.cl](http://www.corfo.cl) a notice that reports the modification of the table in section 2.4 on the “RFI Stage Deadlines”, and make this resolution available to interested parties.
